REGISTRATION FORM & ARTIST AGREEMENT

This agreement is a legal document between you, the artist, Becky Casting Agency, Talent Management and invoices the following;

- 1. To allow Becky Casting Agency to act on your behalf with production companies.
- 2. Becky Casting Agency will place your information, photos and database, and use the information to promote you to production companies on the internet and other social media platforms.
- 3. Becky Casting Agency charges 30% booking fee, once off (T/C can change depending on the type of job).
- 4. If Becky Casting Agency cannot find you work, you cannot hold Becky Casting Agency liable.
- 5. The power of attorney allows Becky Casting Agency to sign contracts on your behalf.

YOUR OBLIGATIONS

- 1. Keeping accurate records of the dates, time and places you have worked.
- 2. Being punctual. If found 10 minutes late for the shoot 25% off your day rate will be deducted
- 3. Informing the office in reasonable time if you cannot make a shoot or casting.
- 4. Bringing three to five sets of clothing to a shoot.
- 5. Keeping Becky Casting Agency informed about changes in personal.
- 6. SHOULD YOU CONFIRM AVAILABILITY AND DECIDE NOT TO PITCH ONSET, YOU WILL OWE BECKY CASTING FOR THAT DAY RATE AND YOU WON'T BE BOOKED FOR 90 DAYS.
- 7. YOU ARE NOT TO RECEIVE OR DEMAND ANY PAYMENT FROM PRODUCTIONS THAT BECKY CASTING GETS YOU.
- 8. YOU ARE NOT BE FOUND DISCUSING OR SAYNG ANYTHING BAD ABOUR YOUR AGENCY.
- 9. YOU ARE SIGHNED AS BECKY CASTING ARTIST FO A FULL YEAR.
- 10. YOU ARE TO PAY FULL AMOUNT OF REGESTRATION.
- 11. YOU ARE MANDATED TO ATTEND WORKSHOPS DONE ONCE IN EVERY MONTH TO IMPROVE YOUR ACTING.,
- 12. SHOULD YOU BE REQUIRED TO ATTEND ANY MEETINGS REGARDING YOUR AGENCY, YOU MUST AVAIL YOURSELF.
- 13. YOU UNDERSTAND THAT 25% PAYEE IS DEDUCTED FROM EACH AND EVERY JOB YOU GET AND YOU CAN NOT HOLD YOUR AGENCY LIABLE FOR SUCH AS IT IS A SOUTH AFRICAN GOVERNMET LAW.
- 14. YOU UNDERSTAND THAT BECKY CASTING CHARGES PRODUCTIONS COMPANIES 30% BOOKING FEE, WHICH IS INCLUDED IN WHAT EVER RATE WHICH WILL BE NEGOTIATED TO BE CONSIDERED AS YOUR FEE PER DAY.
- 15. YOU ARE TO KEEP BECKY CASTING OF ANY CHANGES REGARDING YOUR ACCOUNT DETAILS, PROOF OF RESIDENCE ETC.
- 16. YOU ARE NOT TO CALL ANY CASTING DIRECTOR FOLLOWING UP AUDITIONS OR CALL BACKS UPDATES.
- 17. YOU MUST HAVE ONE AGENCY.
- 18. SHOULD YOU CHOOSE TO FREELANCE, BECKY CASTING CAN STIL REPRESENT YOU AT NO COST.

19. NO REFUND

20. Should you decide to resign from Becky casting understand that if you are or have any existing or recurring jobs or contracts which you got through Becky castings such will not be affected by your decision or the agencies of terminating the contract or resigning. Becky castings will continue its service with those production companies.
